1. Call to Order

The meeting was called to order at 7:00 pm.

2. Acknowledgement of Champagne and Aishihik First Nations Traditional Territory

Mayor Strand acknowledged that we are on the traditional territory of the Champagne and Aishihik First Nations.

3. Adoption of Agenda

5. Adoption of Minutes of Regular and Special Council Meetings

a. Draft Minutes December 17, 2025

10. New Business

a. Accounts Payable to January 14, 2026

Discussion:

- Noted that the cost of the installation of the view monitor was higher than expected.

b. Wildfire Community Preparedness Day Application

Treasurer's Presentation:

- \$500 grant to go towards conducting a Wildfire Community Preparedness Day. The Village staff put an application in.

Discussion:

- Noted that this was a Village of Haines Junction application for a grant for a community FireSmart event.
- Mentioned that the late Councillor McPhee conducted a similar event in 2025.

c. Power Outage with ATCO

Councillor Sundbo's Presentation:

- This was a big event in the community when it was extremely cold. The Councillor would like to know more about what caused it to mitigate the risk of this happening again. It might be appropriate to ask staff to reach out to ATCO for information about what precipitated the power outage and to thank them for their speedy response. Does ATCO have personnel living in Haines Junction? Did this have any part to play in the response? Looking to avoid future issues.

Discussion:

- Staff should be requested to conduct a debrief to include lessons learned about this event to better prepare for future emergencies.

THAT Village of Haines Junction staff contact ATCO and ask them for more information about the recent power outage, causes, lessons learned and plans to avoid outages like this in the future if possible.

THAT Village of Haines Junction staff conduct a debrief for Mayor and Council regarding the recent power outage and discuss lessons learned and how we can improve our emergency response in the future.

11. Bylaws – Reports, Readings and Adoption

a. Bylaw #436-25 Short Term Rental Accommodation Moratorium – For 3rd reading

Discussion:

- This version includes a list of the existing schedule.
- One participant doesn't have all the information filled in. Fourth listing, second page, is missing the providers.
- Only 8 short-term rentals. Do all 8 have business licences?
 - Yes.
- How many of these don't have Village of Haines Junction business licences?
 - One.
- In Section 5.8., what does "impact to neighbours, neighbourhood noise, parking lots" mean? Is this a reason to deny? It appears to be a reason to deny in case of nearby residents complaining of noise.
- Why is C here? Full home vs. mortgage helper?
 - Difference between renting out the full home or the rental suite. Consider changing the wording and taking out 'mortgage helper'.
- Noted that this bylaw isn't a short-term rental by-law but rather a moratorium. This is the list to show applicants who'd like to undertake short-term rentals what is required to approve their request.
- It was noted that CAO Fairbank or a by-law officer should have a conversation with the one applicant who doesn't have a business license, to discuss this with them as the licence is a requirement.

THAT Bylaw #436-25 Short Term Rental Accommodation Moratorium is read for the third time and final time on the 14th day of January 2026.

Motion #05-26 was **CARRIED**.

b. Bylaw #437-26 2026 Municipal By-Election – For 1st and 2nd reading

Discussion:

- Mayor Strand will not be in the Yukon in time to vote in the by-election, nor with a special ballot. Discussing other options for the special ballot. She's requesting that voting take place on March 5th, 2026.
- The Order in Council stipulates that the time set by Council to make nominations must end no later than February 16th, 2026. The third reading could take place on February 11th, 2026.

THAT Bylaw #437-25 2026 Municipal By-Election is read for the first time on the 14th day of January 2026.

- Attended the New Year's Eve celebration at the Da K' Cultural Centre and noted they were amazing. Thanked the CAFN and the fire department.
- Thank you to the fire crew for their quick response in addressing a house fire emergency.
- Thank you to ATCO for addressing the power outage and their quick response.
- Thank you to all the Village of Haines Junction employees with the snow removal.
- Mentioned thinking of our neighbours in Alaska and their declared disaster zone, avalanches and snow and rain.

Councillor Sundbo

- Next weekend he will be out of the community.

Mayor Strand

- Had a discussion with Senator Pat Duncan. Should have met yesterday but will meet via Zoom on Friday to discuss the Arctic Winter Games. The Nordic ambassadors will be coming in March 2026 and they'd like to know if Haines Junction will host them.
 - Is Council open to hosting?
 - Yes.
 - How many ambassadors are there?
 - Unknown.
 - Mayor Strand will update the Council by email after her Friday's meeting.
